Administrative Comments

Trisha Kelly with Trisha's Financial Solutions LLC provided administration for the 2022 fiscal year on a month-by-month basis. The Dickinson office was assessed as not being ADA compliant and a search for a new location that would meet guidelines was explored. Due to parking situations changing at the downtown Dickinson office location, RCRC's car was sold this year.

Projects that were currently active in the previous year were administered as usual and business conducted to maintain the current status of RCRC. RCRC is in excellent financial condition at the end of this fiscal year. The organization is looking forward to positioning itself to create greater participation in programs within the service region.

The revolving loan funds have no current delinquencies. There are no new loans FY2021. Community Development Block Grants are proceeding.
